Words to know

■ Fixed Account¹

Credits an established rate guaranteed for the first contract year; afterwards, renewal rates are declared annually.

■ Dual Trigger²

At the end of the one-year indexed term, if the index has a positive change or remains flat, your account is credited the trigger rate. If the index change is negative by less than the value of the trigger rate, the difference is credited. If the index is negative by the value of the trigger rate or more, your account is protected from loss, but no interest will be credited.

■ Trigger²

At the end of the one-year indexed term, if the index has a positive change or remains flat, your account is credited a specified rate. If it's negative, your account is protected from loss but no interest will be credited.

Trigger lock offers a guaranteed rate determined by the surrender charge period. Funds can only be allocated at contract issue, and reallocated at the end of the guaranteed rate period.³

■ Cap²

At the end of the one-year indexed term, the beginning and ending values of the index are compared to calculate the percentage change. If the change is positive, your account is credited the full percentage change up to an interest cap. If the result is zero or negative, your account is protected from loss but no interest will be credited.

■ Spread²

At the end of the one-year indexed term, the beginning and ending values of the index are compared to calculate the percentage change. If the change is positive, your account is credited the full percentage change minus a spread. If the result is zero, negative, or less than the spread, your account is protected from loss but no interest will be credited.

■ Participation²

At the end of the applicable indexed term, the beginning and ending values of the index are compared to calculate the percentage change. If the change is positive, the account is credited the percentage change multiplied by a participation rate. If the result is zero or negative, your account is protected from loss but no interest will be credited.

Multi-year participation offers a guaranteed rate determined by the surrender charge period. Funds can only be allocated at contract issue, and reallocated after the five- or seven-year indexed term.³

Withdrawals may be subject to a surrender charge (9% maximum) and a Market Value Adjustment.

¹ Fixed Account interest rates are annual effective rates. Interest is credited daily to obtain an annual yield equal to the annual effective rate (assuming no withdrawals). Guarantees are subject to the claims-paying ability of The Lincoln National Life Insurance Company.

² Availability of indexed accounts may vary by firm and state. Applicable indexed interest is credited at the end of the indexed term. Amounts withdrawn (including amounts paid as a death benefit) before the end of an indexed term will not receive indexed interest for that indexed term.

³ For *Lincoln OptiBlend*® 10, funds can be reallocated after the initial five years. If no reallocation is made, the accounts will auto-renew and a new five-year rate is declared. After two five-year terms, it terminates and funds can be reallocated.
